# 3. BARONIAL STATEMENTS

# 5. JUNE 2020 COMMITTEE UPDATES

# 5.1 June 2020 Long Weekend Updates

The Committee for the June 2020 Event is composed of:

The first face-to-face meeting was held on 14 September.

It is hoped that the Town Meeting will be held in 6 weeks time (tentatively proposed for 8 November) and a survey monkey will be conducted following this.

Skjaldadís advises that she will be heading back to Singapore in October and has no firm return date yet. Devine Winter encourages Skjaldadís to respond to the survey monkey.

Nathan of Dragons Bay and Konrad Hildebrandt arrived at 12:13pm.

Devine Winter encourages non-members to join the SCA to ensure their voice is heard and have weight behind it. This is especially true in regards to this June 2020 event as it is traditionally heavily attended by those whom are non-members. Currently, SCA policy may allow for a weighting of 25% to the voice of non-SCA members, whilst financial SCA members have 100% weighting to their voices.

It is envisioned this weekend event shall become more of a Festival-type event, keeping some elements of what that weekend used to be, and integrating elements of Konrad's 'Harvest Feast' bid proposed at Anealan Council. Once a framework has been established then the Committee will put this proposal to the populace for their feedback and consideration.

Liduina asked where the event may be held. Devine advised that it is likely Wandi as it provides scope for archery. Other venues have been considered. Some examples include the Mandejal Activity Centre in Karrakup and scouting venues.

Mandejal site does not allow for use of personal archery equipment. Archery would require populace to use the Mandejal-provided archery equipment and their marshal, at a cost of approximately \$200.

Some of the Scouting venues that were appropriate for use otherwise would be dry sites, which would exclude some of the attendees whom engage in responsible drinking.

Blackglove asked if there was a timeline for finalising the event. Devine Winter advised it is estimated a 3 month process.

Town Hall will not be held at Wandi. Liduina asked where it would be located instead. Devine Winter advised a central location, possibly Cockburn area, to allow easy access along the freeway for those traveling from further destinations.

Populace are invited to send thoughts to the Seneschals. All elements are open for discussion, with no thought or opinion veto'd outright. A curation of messages will be read at the Town Hall meeting to ensure concerns are raised.

# 8.1 Officer Reports

Agenda was held up this month due to reports submitted late.

Slaine, Andy, Avalon and Skjaldadís would like a copy of the standard report template. Gummi to send a copy to all Officers for their use should they desire. Officers were reminded to submit reports in Word/doc format.

# **A&S Minister Report Comments**

Skjaldadís advised of difficulties organising Scribes at Wandi.

Ilaria hosts Scribes more often than not on Monday evenings at her abode in Gosnells (7-9pm). Ilaria welcomes Dragons Bay populace to attend. It is encouraged for Dragons Bay populace to attempt attending Monday weekly evening sessions, which are situated in a southern location.

Skjaldadís proposes for Official A&S to be held at Wandi Clubrooms fortnightly concurrently with archery training (possibly 2nd and 4th weekend of each month), to be hosted alternating between Skjaldadís and Slaine. This allows for no cancellation of training due to inclement weather; archery training turns into maintenance for targets, arrows, bows, alongside A&S projects.

Wednesday night A&S at Slaine's house will be returning later during the year, running concurrently with armoured/rapier training.

Skjaldadís to advise Gummi of the dates she will have casual A&S gatherings at her abode.

Slaine notes it is optimal for A&S gatherings to be held at neutral spaces such as Wandi Clubrooms, so that loyalty remains to the group rather than to a place or people.

Blackglove is considering Cooks Guild to run concurrently as archery training, alternating with A&S fortnights. Blackglove proposes to coordinate this with Skjaldadís to balance with A&S gatherings, and increasing the functionality of the space when hiring the grounds.

Skjaldadís encourages populace enters A&S for Baronial Championship.

# 9. GENERAL BUSINESS

## 9.1 Committee for Regalia

## Definition of 'Regalia':

For the purpose of this proposal; "Regalia" to be defined as such property items as may be used in court or in the conduct of their duties by any of the officers or champions and such amenities as may be permanently made for the use of landed nobility, royalty or special guests attending Dragons Bay events. Including court banners or field banners to be displayed adjacent to the list field or similar related decorations.

Blackglove advises that forming this Committee and a policy will provide direction, ensuring items donated and created have long-term durability and usability.

Slaine notes that there are tabards in the Abertridwr assets and fabric. Pending the outcome of the Abertridwr funds and assets, these assets may be added to Dragons Bay's.

Slaine is happy to donate fabric from her home stash toward the creation of banners and tabards. Liduina advises she has a tub full of material in heraldic colours that she will donate to be used for creating banners.

Avalon would like the chair covers for Dragons Bay to be prioritised and finalised (via an A&S gathering) prior to the Yule Feast in December.

# 9.3 Champion of the Bow Regalia

Blackglove proposes that each Champion of the Bow receives the perpetual "Dragons Scale" guiver.

On handing the quiver to their successor the previous Champion shall have placed within the quiver an arrow fletched with their personal livery. Marked upon the arrow to be their name and year of winning the title.

Alexander Cochrane forged a steel arrowpoint to donate as a past Champion. Nathan intends to create an arrow for this, with Dragons Bay fletching (white and green). Both their names shall be on this arrow. Nathan will also add one of his own to this quiver.

In addition there is a Champion's Bow and Champion's Knife which are considered part of this regalia set.

#### **Recommend:**

Dragons Bay Council supports the implementation of the perpetual quiver with each Champion of the Bow to:

- 1) Become custodian of the guiver whilst they are Champion of the Bow
- 2) Create an arrow fletched in their colours, marked with their name and year of winning the title, to remain with the quiver upon handing it over

# 9.4 Champions of Dragons Bay

As populace grows, so do the numbers of those who long to test their worth. There are now those skilled in several different arenas, beyond the field of archery.

It is timely to consider expanding the Dragons Bay event of 'Champion of the Bow' to a Dragons Bay Championship, to allow those whom wish to contest for such titles in the areas of archery, armoured combat and the arts & sciences. Rapier is yet to establish firmly in Dragons Bay, however scope should allow for a Champion to be sought in the future.

As there are a number of youth actively participating in Dragons Bay, it is appropriate to consider Youth Champions for each of these disciplines.

Avalon proposes that "Champion of the Bow" remains at Boddington as a single-day event An entire Championship-style event would require the event to be held across an entire weekend.

Concerns were raised regarding Boddington's suitability for a higher capacity of attendees. Inter-College War has been held previously at Boddington, which had possibly 50-60 people attending, with 2 portaloos and drinking water (via 1000L tanks).

It is noted however that since this event the camp kitchen has been converted into a workshop. Without these facilities an event may require a commercial kitchen to be brought in.

It is believed among some of the populace that a Champion of the Bow event would constitute an element of hunting in the woods. Mobility and accessibility issues may exclude some people participating in 3D animal shoots despite a 'low' course being available, giving an unfair advantage to others.

Devine proposes that the Boddington site requires a feasibility study in terms of capacity, especially with water restrictions in mind. The requirement to bring in portaloos, showers and a commercial kitchen could make this a costly event to recoup hiring these facilities. It is important to bear in mind that the destination could also dissuade attendance by those living north of the river.

Discussion was held around holding Champion of the Bow at Boddington, with other Champions sought at a different venue and weekend. It is generally accepted that all Champions should be sought on the same weekend.

Skjaldadís suggests considering a different site for Champions altogether.

Blackglove asked for the addition of past Champions on the website.

The proposal for next year's AGM could include considering one (1) possible qualifying event from three (3) events for seeking Champion of the Bow (eg. 3D target; an IKAC; novelty shoot). The best score of these would assist with qualifying for entering the Champion of the Bow event.

Skjaldadís is to consider regalia for each proposed Champion's discipline and present these at the next Council meeting.

  - a) Champion of Armoured Combat (& Youth)
  - b) Champion of Arts & Sciences (& Youth)

# 9.5 Additional Key

# 9.7 Period Toybox Joint A&S Project

With new Officers and a growing youth contingent, it is proposed for both Aneala and Dragons Bay to work together on a period toybox. This would be a chest filled with various period toys, such as jointed dolls, balls, games and the like, that could then go to events. Not only would this have use by children at events, but could be an item present at demo's to showcase other skills of the groups to the public to show that Dragons Bay is child-friendly.

This proposal is for a casual, ongoing project that the populace can contribute to over time. It is possible to tie this into the Championship for Arts and Sciences, provided documentation is submitted.

"The SCA Ltd Board (Australia) would like to thank the large number of Members who provided feedback regarding membership fees.

Effective for fees collected from October 1, 2019:

- \* SCA Ltd (Australia) Membership will be \$45.00 per year for adults and non-dependent minors;
- \* Family Minor Membership will remain free of cost to Members, for legal dependents of current adult members.
- \* Adult Event Membership Fees will increase to \$10.00 per event; Minors Event Membership Fees will remain at \$5.00 per event;
- \* Event Membership (reciprocal) for SCANZ and SCA Inc members will remain at \$0.00 per event.

In the next two weeks, guidance will be provided to Seneschals and Reeves regarding administration of the changes to Event Membership fees and recruitment activities.

"Adult Event Non-Membership Fees will increase to \$10.00 per event; Minors Event Non-Membership Fees will remain at \$5.00 per event"

Members from Australia going overseas do not need to pay insurance levies.

Nathan advises that whilst the fee is going up, SCA membership is still comparatively lower than a lot of other clubs.

Devine Winter advises that Little Spoon has been commissioned for a wooden frame for an iPad to be made available to enable people to sign up immediately. There may be consideration toward a mobile payment method later.

There is a steering committee considering subsidising event fees for those holding concessions at the Baronial level.
